1 accident & 1 near miss reported

- 1. A Club member operating a Club RIB for centreboard activities had forgotten to take their access FOB & climbed over the gangway to exit the breakwater while doing so they slipped & fell. This had resulted in cuts & concussion. The individual was taken by a family member to Kawakawa hospital for assessment. Stiches were required for some of the cuts. Remedial actions have been identified & are being implemented: Access FOBs will be attached to the keys on each Club RIB so lack of a FOB for RIB operators is not an issue, signs on the gangways "Do not climb over gangway" will be installed, an article in the Club's weekly notices will address, gangway sidings will be researched & costed for consideration.
- 1. Near Miss: A near miss in the marina fairway was reported by one of the vessel owners involved. Remedial actions have been identified & are being implemented: Marina Matters & Club weekly notices to address; both vessel owners & advise port to port passing applies in the marina & you are expected to abide by them.

The Kerikeri Cruising Club Marina Committee has considered & accepted the proposed Club Asset Refurbishment Cost with a request to clarify the demarcation between the reclamation carpark & the access driveway. A proposed demarcation was circulated to the General Committee for consideration.

5.1 Marina Pile Replacement Recommendations

The Marina Committee recommended that replacement of 68 piles (28 year 1, 20 year 2, 20 year 3). Background was circulated with the agenda. The replacement recommendations were generated by the annual internal pile audit.

It was confirmed that the refurbishment accounts currently have sufficient funds to cover these replacements. Due to the scale of expenditure an engineer is required to supervise the project.

It was noted that the marina must be insured, to maintain insurance it must be maintained & refurbished. There are plans to increase the refurbishment funds for future requirements. Current refurbishment funds are estimated to cover E pier & pile replacement refurbishment projects.

The first step is to get proposals for an engineer to draft the tender documents, pile specifications & supervise the installation for replacement of 68 piles over 3 years (28 year one & subsequent years to be confirmed by the annual pile audit). As per the Club's Procurement Policy, at each step there is an internal approval process that provides regular opportunities for checks & alterations to be made.

Resolution:

That:

- 1. proposals for an Engineer be sought (as soon as practicable) to run the procurement & installation of 68 piles (over 3 years) in the marina, &
- 2. a tender process, compliant with the Club's Procurement Policy, be undertaken (as soon as practicable) for replacement of 28 piles in the 2023/2024 year, &
- 3. the tender process also includes replacement of an additional 20 piles in the 2024/2025 year & 20 piles in the 2025/2026 year with these additional pile replacement subject to confirmation during the annual pile audit.

5.2 Marina T-head Recommendations

The Marina Committee recommended that refurbishment of the T-heads on C pier & to a minor extent D pier be undertaken as identified in the Shorewise Marina Condition Report. Background was circulated with the agenda.

It was confirmed that the refurbishment accounts currently have sufficient funds to cover these projects.

- 4. proposals for an Engineer be sought to run the procurement & installation of T-head refurbishment as per the Club's Procurement Policy, &
- 5. a tender process, compliant with the Club's Procurement Policy, be undertaken (as soon as practicable) for refurbishment of the C pier T-head components & D pier pile guide.
