Please note:

- Kerikeri Cruising Club Marina is a private recreational marina. Unless the Club agrees otherwise in writing, the marina berths shall be used for recreational purposes only by the Licensee. Commercial operations including the loading/unloading of paying passengers, customers, accommodation guests, service contractors or business materials is prohibited at this private facility. This means no commercial fishing, diving or boat charter vessels unless prior agreement in writing is obtained.
Each person on the list will receive one offer to purchase a berth license. If this one offer is declined (or not responded to) the name will be removed from that list. Where a person is listed on two or more lists, they will receive one berth license offer per list.
Vessels must fit within the boundaries of their allocated berth (i.e. must not protrude over the pier walkway or beyond the piles). Please ensure that the berth size preference you have indicated is the correct one to accommodate your vessel by checking the vessel's length overall (don't forget bowsprit, anchor, dinghy davits, and duckboard). The berth sizes below indicate the overall length of the berth e.g. a 14m berth is 14m long so any vessel to be accommodated in this berth must be less than 14m in overall length with enough margin between the vessel & berth lengths to allow safe mooring.
Full Eligible Club membership is a condition of obtaining and retaining a position on the waiting list to purchase a berth license. Member must permanently reside inside the territorial boundary of the Far North District.
Owners of jointly owned vessels maybe required to attend an interview with the Marina Committee to establish validity of ownership of the vessel.
Negotiations on the transfer price of a berth license occur directly between the vendor & purchaser. As part of these negotiations your name & contact details will be released to license vendors for the purpose of instigating negotiations.
If the offered licensed berth contains an intermediate pile the prospective purchaser has the right of refusal and will retain their position on the berth purchase wait list.
As of March 2020, the Club no longer accepts license transfers to partnerships, companies or trusts.
