6.6 Long Distance Membership

Resolution:

"A Long Distance member shall be: A Member (and Spouse) who permanently reside more than 100 kilometres Radius from the Club Rooms."

Change to

"A Long Distance member shall be: A Member (and Spouse) who permanently reside outside the Far North District Territorial Boundary."

The Club will now strictly apply the long-distance membership category to members joining the Club after 15 June 2021. That is, "A Long Distance member shall be: A Member (and Spouse) who permanently reside more than 100 kilometres Radius from the Club Rooms."

Standard residency evidence (rates or amenity invoices) may be required as proof of residency.

Where doubt exists uses the electoral roll as the final indicator of residency.

Corporate addresses (e.g. company office) will not suffice as proof of individual residency.

P Wilson will investigate a \$100 entrance fee be charged to applicants applying for full membership (family & senior).

6.7 Change to the Constitution's Objects

To clarify the purpose & intent of the Kerikeri Cruising Club it is recommended that the objects of the Club be amended.

8.2 FNDC Significant Natural Areas (SNA) - M MacDiarmid

Far North District Council is looking to include SNAs in a new District Plan. KCC has a potential SNA on its property. SNAs may impact on ability to develop land, remove vegetation etc. Opportunity for formal submissions later in 2021 when proposed District Plan is notified. Update: due to public pressure FNDC has put the SNA proposals on hold awaiting clarification from central government.
