# 3 Health & Safety

3.1 Incidents

2 incidents had been recorded during the previous month.

Accident: A Club member operating a Club RIB for centreboard activities had forgotten to take their access FOB & climbed over the gangway to exit the breakwater while doing so they slipped & fell. This had resulted in cuts & concussion. The individual was taken by a family member to Kawakawa hospital for assessment. Stiches were required for some of the cuts.

Remedial action:

Access FOBs will be attached to the keys on each Club RIB so lack of a FOB for RIB operators is not an issue.

Signs on the gangways "Do not climb over gangway"

Near Miss: A near miss in the marina fairway was reported by one of the vessel owners involved.

The Club's Marina & General Hazard Register was tabled to the committee & discussed. The register is updated in regular (approximately 2–3 meetings per month). As a result the register will be digitised for index & searchability purposes.

Haul out snatch block has been repaired, NRC tested the haul out area 10/7/2023

Pile wear strips fitted but noted that this is ongoing work, new cleats on E32 (larger), new navigation light fitted, pile audit completed, remainder of piles to be audited,

E pier walers will be bored & counter sunk before treatment, finger walers will be treated after counter boring.

Pile rings are becoming impossible to install "in-house' due to the height of the piles. Vessel options to be investigated & costed.

Electrical cables on breakwater checked & all appear to be in good condition. New service lids fitted on C pier.

A pier finger connection bolts ready to be installed.

Septic system has a simple float to indicate high level after electrical float switch failed.
